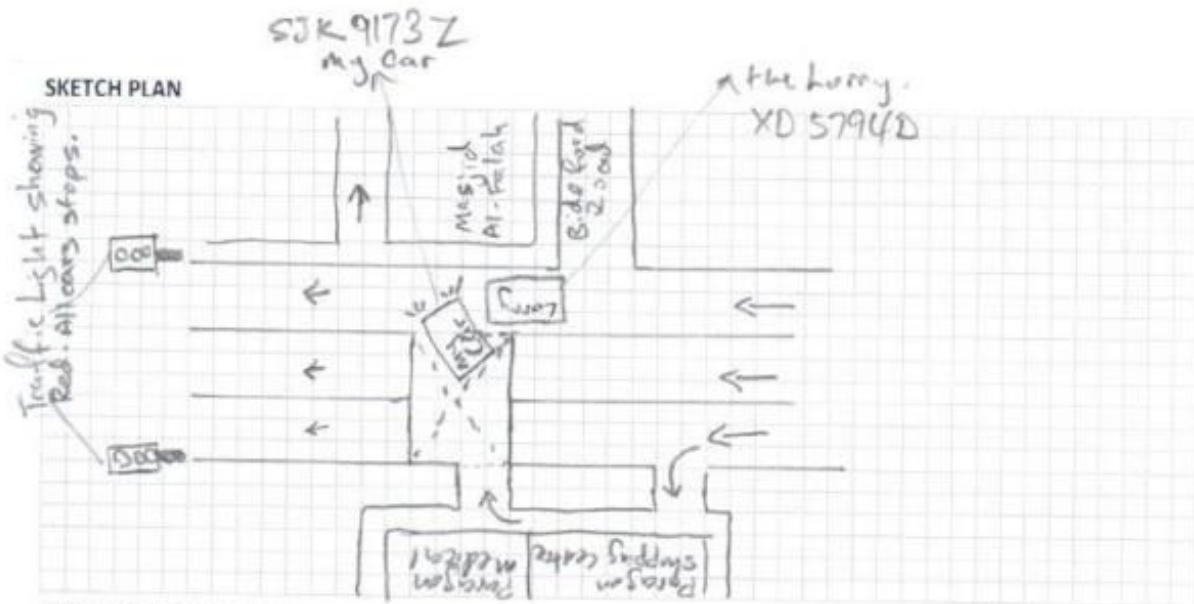

DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

I was driving from the drop off point at Paragon Shopping Centre towards the exit to Bideford Road. It is Red Light traffic along Bideford Road and beside Thong Sim Building. All the cars stops and stationary.

The Road Marshal from Paragon Shopping Centre stop the cars along Bideford Road and guide cars from the Paragon Exit out to Bideford Road. My car follow the guidance of the Road Marshal and drive out to the Yellow Box and towards the right most lane. My car stop halfway out to the right most lane as there is a car on the 2nd Lane and I was not able to do a full turn out to the right most lane. At this point of time, the traffic light is still showing Red light and all cars remain stationary and stop. The Mitsubishi Lorry is on the right hand side of my car about 5 metres away. When the traffic Light turn green, the Lorry start to move forward.

I was shocked as I am not able to fully turn into the right most lane as the car at 2nd lane has not moved yet. My car was stationary and I keep honking at the Lorry to catch his attention as to stop his Lorry from moving forward. Despite the continuous honking, the Lorry did not stop and knock onto my car. My car was signalling to the Right all the way from the exit.
