### ACCIDENT INVOLVING SLL 7939R(OI - LCR) & SKV 4896J(TP) ON 07/12/2017

We refer to the above matter.

Third party reported that he was traveling at the 2<sup>nd</sup> lane along Aljunied road turning right into Geylang road. Suddenly, our insured driver who was on his right lighted up her left signal light and went straight without checking as resulted the accident.

Our insured driver reported that she was turning right to Geylang road, suddenly third party swiped across her left portion and collided onto her car.

Third party had submitted accident scene photos for our consideration. Based on the accident scene photos and the position of both vehicles, we are of the opinion that third party version is more probable. The position of our insured vehicle seems that she is attempting to travel straight. If our insured driver was making a right turn, the position of her car is likely same as the car(pink colour) behind of our insured vehicle.

In view of the above, we would like to propose to settle the matter at best.
