I hereby declare that the following statement is voluntarily made by me for insurance purpose. This statement is true and correct to the best of my knowledge and belief.

I am the above mentioned person and the registered owner for the vehicle, an Audi Q6 (A) bearing registration number **SKG1205C**.

I obtained my class 3 Singapore driving licence on 14 May 2014 and I have 4 years and 7 months of driving experience prior to the accident.

From my recollection, I was not involved in any other road traffic accidents in the past 3 years.

On Thursday, 28 December 2017 at about 1255 hours, I was driving the above vehicle and was travelling alone.

I was traveling to a nearby shopping centre in the vicinity of Joo Chiat from my residence located at Joo Chiat Terrace.

On that day, the weather was clear and the road surface was dry. The traffic condition was moderate.

I was travelling along Joo Chiat Terrace towards Joo Chiat Road.

Upon approaching the non-signalised T-junction between Joo Chiat Terrace and Joo Chiat Road. I was traveling in the left lane of the 2 way road at an estimated speed of 20km/h.

As I had intention to execute a left turn into Joo Chiat Road, I switched on my left signal and approached the stop line.

I then came to a complete stop and checked for traffic along the right side of the road. At this juncture, I observed there was a stationary lorry along Joo Chiat Road.

As the lorry was stationary and from what I could observe there was clear traffic to my right. I proceeded to execute a left turn.

Suddenly, I felt an impact to the front portion of my vehicle and realised that I had collided into vehicle SLP2104U which was traveling along Joo Chiat Road.

After the accident, I alighted from my vehicle and approached vehicle SLP2104U.

I observed that the driver a male Chinese in his 50's was traveling with a female Chinese passenger in her 50's.

Both parties did not suffer any visible injury and did not complain of any pain.

The passenger on board the other vehicle, subsequently left the accident scene in another vehicle.

I noticed there was minor damage to the left rear portion of the other vehicle.

Subsequently, as there was no injured parties, we proceeded to exchange particulars and left the accident scene.

The driver of the other vehicle was agreeable to a private settlement, however he contacted me later on and advised that he needed to report the accident to Insurers as his passenger claimed that she was injured in the accident.

Traffic Police and ambulance did not attend to the scene.

As a result of this accident I did not suffer any injury.

My vehicle was not fitted with an in-vehicle camera and I have no eyewitnesses to provide.

The following questions were posed to me by the Recorder ;

Qns 1) Did you lodge a Police Report?

Ans : No I did not.

Qns 2) Did you take any scene pictures?

Ans : No, I did not.

Qns 3) Why have you not lodged the SAS yet?

Ans : As the damage to the other vehicle was minimal, we initially agreed to settle the accident in private. However the driver contacted me later on and informed me that he had to report the accident as his passenger was injured.

I wish to state that 24 hours preceding this accident, I did not consume any alcoholic beverages or medication.

I have been advised and acknowledged that I am required to provide and forward a copy of the Traffic Police investigation outcome to AXA and/ or AJAX Adjusters & Surveyors Pte Ltd upon receipt.

I understand that based on the circumstances and the merits of the case, AXA will take conduct of the claim/s in relation to this accident. AXA shall settle the matter at best in order to minimise costs and expenses, subject to the policy terms and conditions attached with the motor insurance policy.
