ACCIDENT INVOLVING SLP 7446A (OI) & SLH 7035U (TP) ON 31/12/2017


We refer to the above matter.

OI reported that TP exiting from the minor road without stopping collided into OI.

Based on both party report third party vehicle is exiting out from minor with a stop line. OI which traveling on the main road was making a right turn into the minor road.

We are of the opinion that BOLA 10a is applied and liability is not in third party favour.
