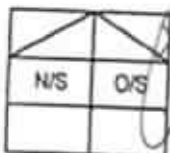

Brief Details.

On 01/01/2017 at about 0715hrs, I was travelling in my vehicle (SHC5374C) along ECP towards Airport on the extreme right lane of 4 lane road along with 03 passenger. While driving along the said location, suddenly one vehicle (SHC3189J) from the 3rd lane of 4 lane road drove into the onto the extreme right lane and collided onto the metal railing.

I then applied the brake to slow down my vehicle and steer to the left wanting to overtake his vehicle. However, in the midst of over taking the said vehicle after it had collided onto the metal railing, it bounced back and collided onto my front right portion of my vehicle. I then drove my vehicle to the right side of the road to avoid any obstruction to other vehicle. I then exited the vehicle and checked if anybody was injured.

Subsequently I called for Police, shortly after both Police and Ambulance had arrived we were checked by the paramedic and nobody was conveyed. We were then advised by one of the Traffic Police officer to lodge a Police traffic accident report.

On the same day at about 1100hrs, I went over to HealthLine Family Clinic & Surgery Pte Ltd located at Blk 25A Chai Chee Road #01-467 for a checkup as I felt some pain. I was then given 03 days medical certification.

I am lodging this report as instructed by the Traffic Police officer.
