Brief Details.

On the same day at about 1700hrs, I returned to my vehicle and did not make any checks on my vehicle and left the location as there is nothing suspicious about my vehicle.

On 02/01/2018 at about 2300hrs, I received a letter from Traffic Police with refence TP/IP/68397/2017 dated 29/12/2017 under TP IO Soh Peng Guan stating that another vehicle (SDV9595C) had an collision with my vehicle on 16/12/2017 at 1630hrs at Hougang Mall B2 car park. I then went to my vehicle workshop and ask the staff to check on my vehicle.

I discovered there are some scratches on the front left side bumper, left headlight area and misalign on the front left headlight. There is in-vehicle CCTV in my vehicle front and rear but however it only records for a duration of 14 days after that it will be deleted automatically and I am unsure if it can be retrieved.
