SJS3634H had stopped to the front left side of my parked car and was unloading some items. As such, his driver seat door was open. While unloading some items, his car seemed to roll back and he tried to rush back in the car to stop the car but to no avail and since his driver seat door was still ajar, it had collided into my car's front left portion. Afterwards, he drove off and parked at another area.

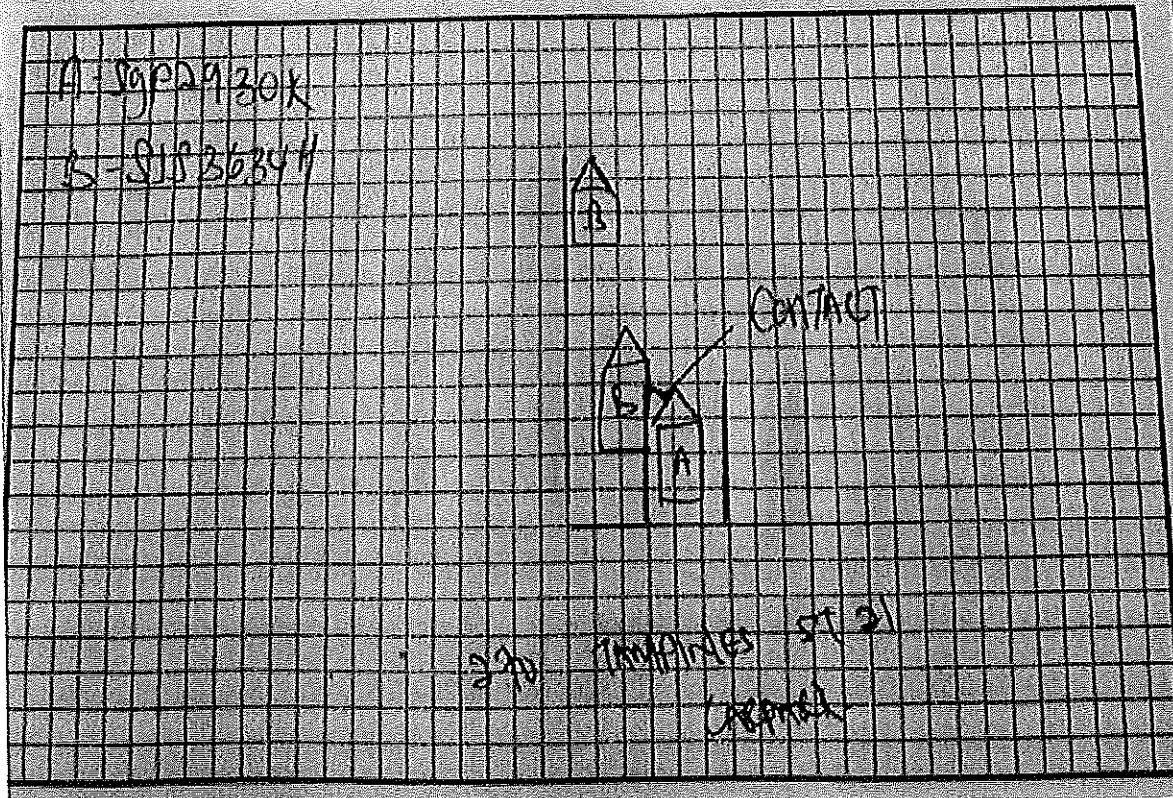



