We enclosed a copy of the estimate from the Third Party claimant with our surveyor's marking and recommendation together with some inspection photos for your reference.

From the enclosed quotation provided by the claimant's repairer, our surveyor after inspection of the claimant's vehicle had managed to reduce the cost of repair from \$8,594.80 to \$4,000.00.

Our surveyor is in the opinion that based on the damages sustained to the claimant's vehicle and the adjusted amount is already fair and reasonable.
