

ON 07/01/2017 AT ABOUT 1430 HRS AT ALONG P1E TOWARDS CHANGI
AFTER BEDOK NORTH ROAD EXIT. I WAS TRAVELLING ON THE
CENTRE LANE AND WHEN MY FRONT VEHICLE SLOW DOWN AND
STOP DUE TO HEAVY TRAFFIC HENCE I FOLLOW SUIT AND CAME
TO A COMPLETE STOP. SUDDENLY I HEARD A LOW BANG FROM
BEHIND AND THE GREAT IMPACT FORCED MY VEHICLE (A)
