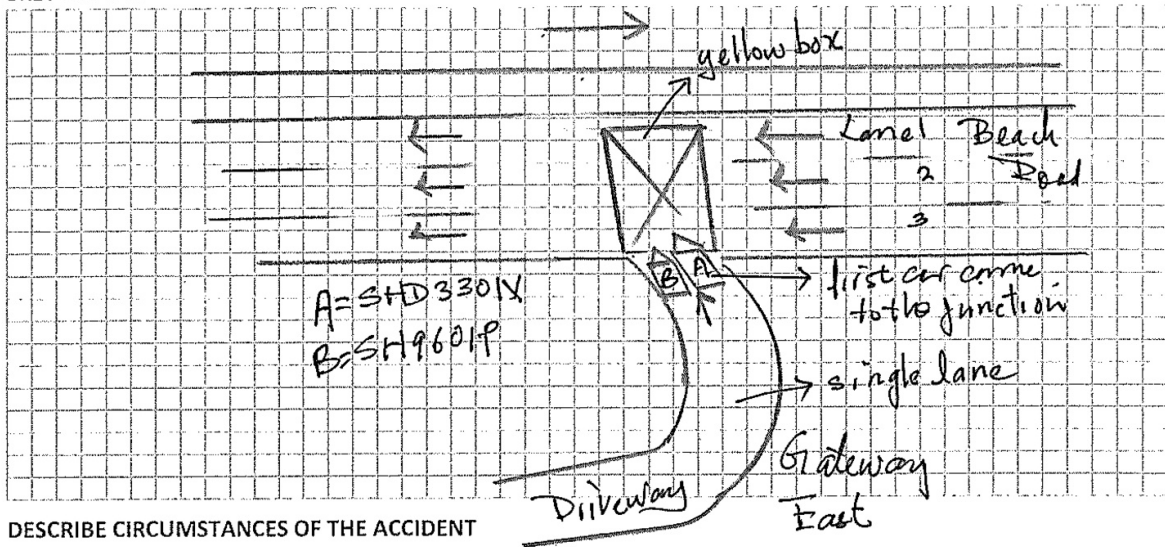

SHD 3301 X - ACCIDENT STATEMENT

I drove off from the drop off point at Gateway East this afternoon(05/01/2018) at about 2.40 pm without passenger in my taxi.

As seen in the video footage, it was a single lane one-way slip road that I travelled along.

There was no sight of car B(SH9601P), another blue colour Comfort taxi when I reached the junction of Beach Road.

I then stopped beside the demarcated white bold arrow on the road before the exit point. I did not stop closer to left flank of the road as I was wary of the road work sign in place before the exit.

As further shown in the video, I set to move out into the yellow box after checking traffic was clear on the main road.

And amid filtering out, my taxi and car B collided at the exit point.

Clearly, this accident was contributed by the driver of car B who came after my taxi to flagrantly halt his car on the left side abreast my taxi on this single lane exit.

I took photos at the scene following the accident.

In the collision, I found the whole left side of my taxi was impaired while the right front of car B sustained dents.

No report of injury at the time of accident..
