1)Mechanical Inspection of vehicle, Motor Car SLF2021C, Motor Lorry YN3985T & Motorcycle FS2114X (TP/IP/41385/2017)

On 07/08/2017 (Monday) sometime before 1934hrs Motor Car SLF2021C was travelling along Woodlands Avenue 12 towards SLE when at the junction of Woodlands Avenue 1 lost control of his car, veered right, mounted the centre divider, overturned and collided onto a Traffic Light pole before colliding onto motorcycle on the opposite direction of the road. Upon Impact the motorcycle skidded to lane 2 and was ran over by a motor lorry. The motorcycle rider died on the spot. Specifically for the motor car SLF2021C, driver informed issue with the brakes system and the CTBA buttons.
