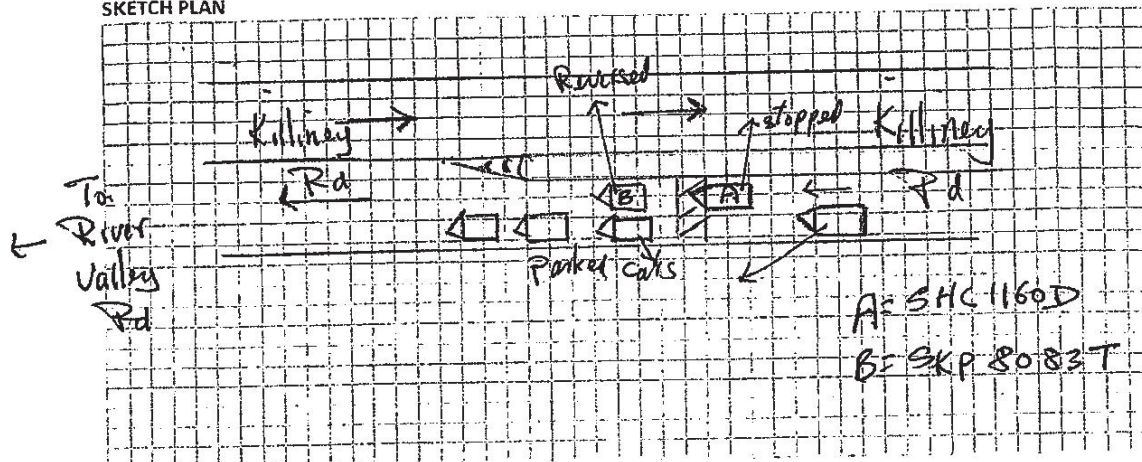

I instantly blared the horn but this did not stop car B from reversing into my taxi.

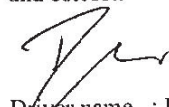
I had turned on the head light all the while.
