Kindly see attached images which clearly shows the gap. So there was no accident that occurred. I have also attached a video which shows that there are absolutely no scratch marks that would result from such claimed accident. The taxi (SHB9981D) suddenly came in front of my car while I was turning right from Buyong road onto orchard road. I did insist on reporting the incident to police on the spot, which is the usual protocol to be followed in such incidents. If the said taxi driver had any doubts that there has been any contact between the cars he should have called the traffic police on the spot. However, the taxi driver showed no interest in approaching police for an accident report and drove off in frustration and anger from Buyong road the onto orchard road near Istana Park. 
