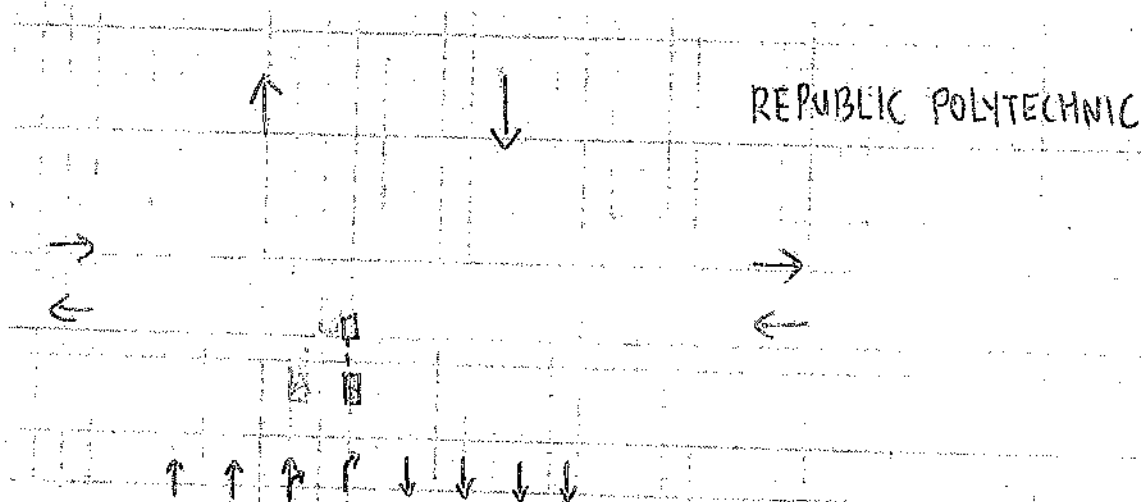

DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

On 9 January 2018, at about 620 am, I was on the second lane of Woodlands Avenue 9. It was red light and I wanted to turn right to Republic Polytechnic. One blue Comfort taxi was on the first lane, towards my right. When the traffic light turns green, I released my brake pedal to move slightly forward, and did not accelerate yet. Suddenly, I felt a bump. When I check, I realised that the taxi has hit the right side of my vehicle. We got out of our vehicles. There are some slight scratches and dents to both doors of the right side of my vehicle. There are scratches to the front left bumper of the taxi. None of us were injured. I believe the taxi driver had made a wide turn while wanting to make the U-turn.
