Dear Mr. Magendran,

We refer to your email below.

We attach herewith the video footage which captured the moment of impact for your perusal.

We append herewith two snapshots for comparison: (Left) a vehicle which was travelling along lane meant for right turning only and (Right) your client's vehicle (in black) at all material time.



Judging from the distance between both vehicles and the center white line, it was clear that your client was travelling along the lane meant for right turning only, and not along the lane meant for going straight and right turning as she alleged, at all material time. Also, in your client's accident report, she stated that she has stopped her vehicle at the traffic junction and suddenly our insured's vehicle side-swiped her vehicle, which was again, inconsistent with what the video footage has shown.

In view of the above, kindly seek your client's instructions to drop hand. We expressly reserve our rights on costs should this matter goes for litigation.
