

My vehs (S4C 94274) driven by S123 2377H Gol Kean Ngua. Minutes enter car park TP BR4 @ Lor Liman. Car park full, so I decided to reverse to the right side to an empty space to move out. Veh SKZ 88897 driven by Mr Foo Jia Yuan S9 537 4541 move to ahead to Veh S4C 94274 causing Veh S4C 94274 to scratch the ~~right~~<sup>left</sup> corner <sup>Bumper</sup> of Veh SKZ 88897 while reversing. Veh SKZ ~~888~~ 88897 left corner bumper suffered slight scratch to the paint work & no dent found on the ~~right~~<sup>left</sup> corner of the bumper. Veh S4C 94274 also suffered scratch on the paint <sup>work</sup> at the right door (back door passenger seat) in the middle.
