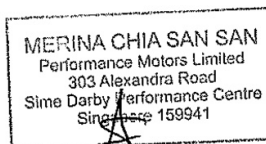

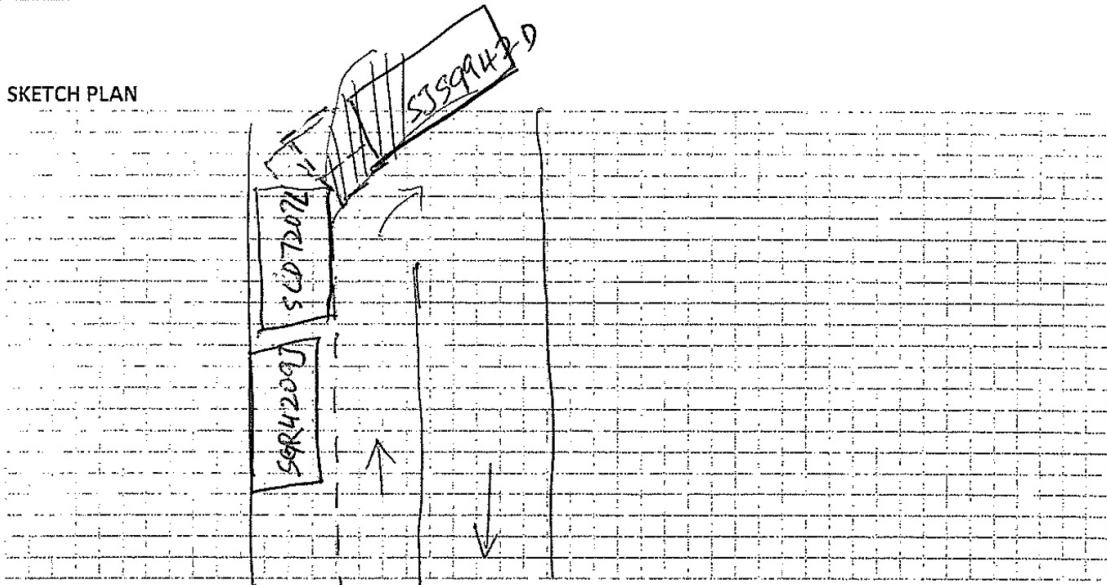

I looked at my rear mirror and saw SGR4209L approaching my car behind. I wanted to move my car further in front but couldn't cos SJS9942D had stopped his car to wait to make his u-turn. SGR4209L could not stop his car in time and bumped into my rear. SJS9942D did not stop his car ~~when~~ even when I wanted him to stop.

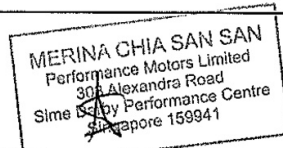
