Brief Details.

On the 15th January 2018 at about 2.45am, I was working and had to pick up 2 passengers, 1 male and 1 female, from Raffles Hotel. I was driving my company's van, PC1404G.

On the same day at about 3.40am, I was at the traffic light junction of Tampines Avenue 4 and Tampines Central 1. I was going straight as it was green light. As I was driving, suddenly a taxi hit my van on the left rear portion. As a result, my van swerved around and hit onto the middle kerb.

My male passenger knocked his head while my female passenger's nose was bleeding. Traffic police and ambulance were called. Both my passengers were conveyed to Changi General Hospital.
