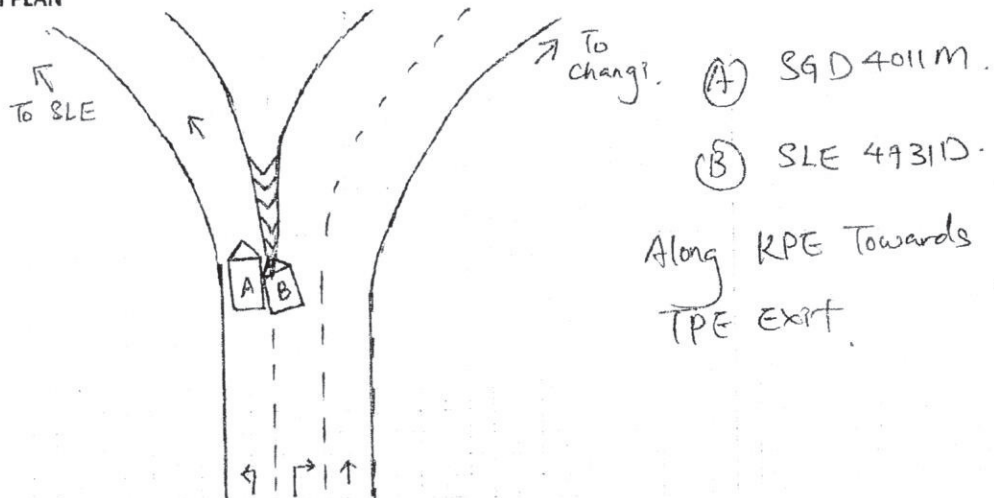

Brief Details.

On 9/1/2018 at about 2000hrs, I was in my champagne gold Nissan car (SGD4011M) together with 02 passengers who were sitting at the rear passenger seats. I was driving along KPE towards TPE. As I was reaching the exit towards TPE, I kept to the extreme left lane as I intended to go to Compassvale Street. I observed that the traffic was heavy and that there were a lot of vehicles queueing up at the exit. I wish to state that there is only one lane at the said exit. As I was nearing the exit (near the Chevrons marking), I observed that there was a white Honda Vezel (SLE4731D) on the right rear view mirror and it did not queue and wanted to jump queue to proceed to the exit. I then kept to my lane and I was driving, I felt an impact from the right side of my car. I then immediately stopped my car. I then alighted from the front left passenger door as the car was blocking my driver side door. Before I could take pictures of the damage, the said male Chinese driver then speed off to the same exit. I then went into my car and followed the said car. As the car was at the pedestrian overhead bridge after Punggol East Flyover, the traffic there was heavy. I then alighted from my car to get the particulars of the other driver. I then knocked on the driver side window to exchange particulars. He then wind down the window and said "si mi tai chi" and wind up the window back. The car was stationary due to the massive jam. I then stood in front of the car to take a picture of the car plate number. As there was space in front of his car, he then drove off with me in front of his car. The car then hit my knees. I almost fell down due to the impact. I then moved to his front left passenger side. As I deem it was unsafe to get his particulars, I then returned to my car to continue sending my passengers back. I also took a picture of his rear plate number and I observed that there was a dent on the rear boot of the said car. I sent my passengers back home and I went back home to rest. On 9/1/2018 at about 2300hrs, I then went to Ng Teng Fong Hospital for my injuries and I was given 05 days of Hospitalisation Leave. There is a camera in my car and I am not sure whether the footage of the incident was taken. Both my passengers witnessed the whole incident and one of the particulars are as such, Helene Bong Hp: 90900934.
