ACCIDENT INVOLVING VEHICLES SKF 6211G AND SHB 7504L ON 22/05/2013

We refer to the above matter.

This is a conflicting version where both OI and TP driver reported that the other vehicle cut to their lane resulting in the accident. Please see attached both OI and TP GIA reports.

There was also no proof provided by both parties to prove the other vehicle cut lane.

We had spoken to the insured previously where she was informed about the TP claim and in the event that if there is no concrete evidence to show TP is at fault, we may have to settle the TP claim at best and we are looking into a 50/50 case and her NCD will be affected. At that point of time, the insured understands and agreed to let us settle and she requested to know the final amount of TP claim before closing case.

Once the amount is finalized at a 50% basis, we had informed the insured about it and at this time, the insured is now disputing on the TP claim and the liability. The insured said that one investigator from McLarens had interviewed her and she said that she already give all evidence she have to the investigator. The insured insisted that she is not at fault. She highlighted to us that she sent a sms to the TP driver asking him to go down to her workshop for the repair of her vehicle and TP driver replied OK but did not showed up. For the insured, she insisted that this reply was the evidence showing TP driver admits at fault. She gave this sms correspondence to the investigator.

We then informed insured that the message response is still not a strong proof that TP driver admits at fault. However, the insured insisted on NOT to settle the TP claim and she is willing to fight the case all the way.

Please advice as TP claimant is chasing for settlement.
