**Circumstances of Accident**

ON 15 JAN 2018, MONDAY AT ABOUT 11:45Pm, I WAS AN UBERPOOL DRIVING TO PICK UP MY NEXT RIDER ALONG SOMERSET RD. AS I WAS APPROACHING THE PICKING UP POINT AT ORCHARD GATEWAY, I DROVE SLOWLY AND CAREFULLY TOWARDS THE PICK UP POINT, I NOTICED FROM MY REAR MIRROR A BLUE TAXI SHC2984L WAS FOLLOWING BEHIND ME VERY CLOSE. AS I NEEDED TO REVERSE TO AVOID THE CURB AND STEEL POLE, I SIGNALLED TO HIM TO MOVE BACK, HE DROVE FORWARD AND HONKED AT ME. AS A RESULT, HIS TAXI COLLIDED ONTO MY BACK BUMPER CAUSING SOME DAMAGES TO THE REAR AND THE BUMPER. IMMEDIATELY I GOT OUT AND QUESTIONED HIM AS TO WHY HE FOLLOWED SO CLOSELY AND DESPITE I SIGNALLED TO REVERSE AND WHY HE STILL MOVE FORWARD AND HONKED AT ME. HE ARGUED AND SAY "NO NO, YOU MUST GO, YOU MUST GO". HE WAS VERY UNREASONABLE AND AGGRESSIVE AND KEEP ON SAYING "THIS IS COMFORT PROPERTY. LET COMFORT DECIDE". I DID NOT WANTED TO ARGUE WITH HIM AND TOLD HIM LETS MAKE REPORT. I DECIDED TO MOVE ON. I HAD TAKEN SOME PICTURES FOR BOTH VEHICLE AND VIDEO AND AUDIO HAD TAKEN AS EVIDENCE. 

**ACCIDENT STATEMENT (2000 characters)**

ON 15 JAN 2018, MONDAY AT ABOUT 11:45Pm, I WAS AN UBERPOOL DRIVING TO PICK UP MY NEXT RIDER ALONG SOMERSET RD. AS I WAS APPROACHING THE PICKING UP POINT AT ORCHARD GATEWAY, I DROVE SLOWLY AND CAREFULLY TOWARDS THE PICK UP POINT, I NOTICED FROM MY REAR MIRROR A BLUE TAXI SHC2984L WAS FOLLOWING BEHIND ME VERY CLOSE. AS I NEEDED TO REVERSE TO AVOID THE CURB AND STEEL POLE, I SIGNALLED TO HIM TO MOVE BACK, HE DROVE FORWARD AND HONKED AT ME. AS A RESULT, HIS TAXI COLLIDED ONTO MY BACK BUMPER CAUSING SOME DAMAGES TO THE REAR AND THE BUMPER. IMMEDIATELY I GOT OUT AND QUESTIONED HIM AS TO WHY HE FOLLOWED SO CLOSELY AND DESPITE I SIGNALLED TO REVERSE AND WHY HE STILL MOVE FORWARD AND HONKED AT ME. 


