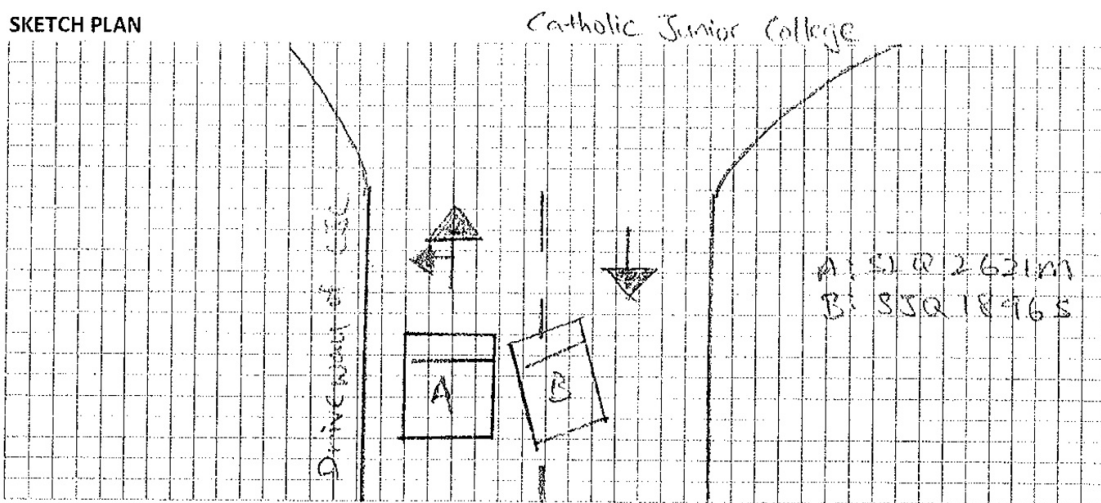


No one was injured at the point of time.


