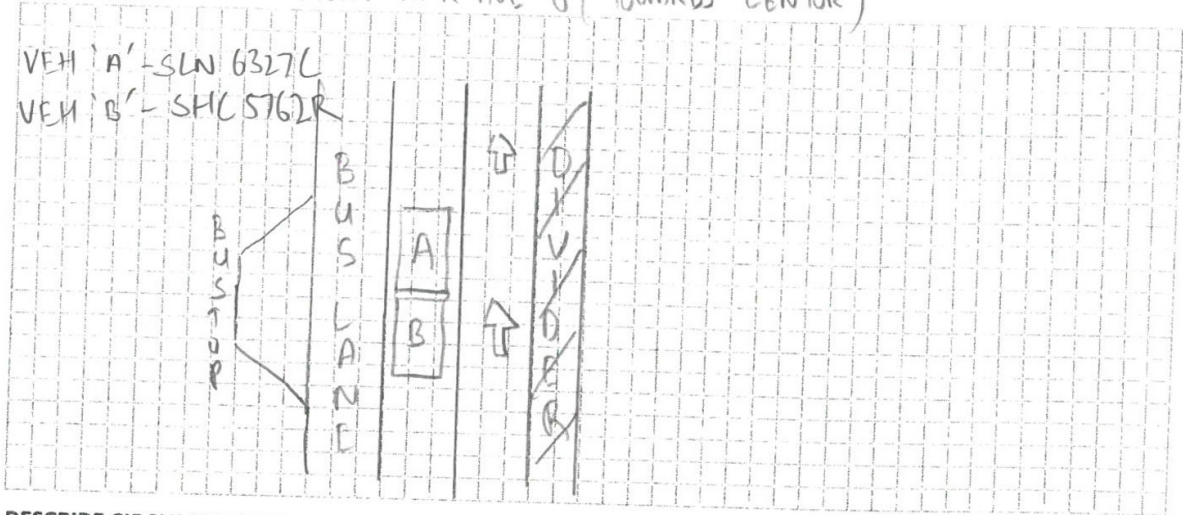


SKETCH PLAN
