## ACCIDENT REPORT: 13Jan2018 - West Coast Sheng Shiong Car Park

- 1) Date/Time of Incident: Sat, 13Jan2018 Approx 10.30am
- Location: Sheng Shiong Carpark at West Coast Road. See Location Map. (Picture A-1)
- 3) Vehicles involved:

Car [A] - SKE 6093K - Greenish Grey Hyundai Avante.
Driven by: Tan Kim Soon, Sgp DL: S0016075
Speed: 0-3 kph

Car [B] - SLS 7450X - Silver Colored MPV (Make unknown). (See Picture D)

Driven by: Chua Geok Toh (65 year old Female)

No Drivers Licence

Sgp NRIC: S 0146987H (Picture B & C)

Speed: Unknown. I would guess approx 5-10 kph. Rounding a bend

and sneaking around Car [C].

- 4) Road Condition: Daylight. Wet after a rain. Visibility Very Good.
- Traffic Condition: Heavily packed carpark. Carpark was full and there were several cars waiting for parking. Car[A] SKE 6093K was one of them. (Picture A-2)
- 6) At about 10.20am, on 13Jan2018, Car [A] driven by Mr Tan Kim Soon, entered the ShengShiong Carpark at West Coast Road. As the carpark was full and there were a few cars waiting for parking spaces, Mr Tan had to wait in the carpark driveway (as shown in attached map: Picture A-1 & 2). Note that the waiting location of Car [A] was immediately after the right bend of the carpark driveway. (See Picture A-2)
- 7) At about 10.28am, Mr Tan noticed through the rearview mirror and side visions and by turning his head, that there was a car (Car[C]) situated at the right rear of his vehicle and the space to the left of Car[C] and behind Car[A] was an empty. A few seconds later Mr Tan suddenly felt a slight bump in the rear of his car.
- Post Collision Observation: Mr Tan got out of the car, and observed that Car[C] that was spotted on the rear right by Mr Tan was still there and at a

safe distance away. There was now a silver colored MPV behind Car[A] that was not there before. It appears that Car[B] had rounded the bend, immediately after Mr Tan had completed his rear surveillance, and collided with the left rear fender of Car[A].

- 9) It appears that my vehicle was hit from behind by Car[B].
- 10) Damage Assessment:

Car [A] - Scratches on the Left of Rear Fender requiring remedial work and painting. Picture G.

Car [B] - No visible damage at point of collision – Right of Front Fender. Picture D, E, & F.

- 11) I was confronted by the Car [B] driver, Mdm Chua who was very aggressive. She loudly scolded and complained that it is her friend's car. Presumably she was scared that she is not covered by Auto Insurance.
- 12) It would be fair to say that in such circumstances where the spaces are tight and the driveway cluttered by many cars looking for parking, that everyone needs to be responsible for keeping the environment safe, and react in sufficient time and good measure to avoid any collision. The cars behind with complete and clear line of vision needs to be responsible for avoiding collisions with other vehicles.
- 13) I intend to fully claim from Car[B] for damages incurred on my vehicle.
