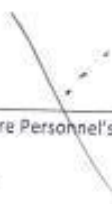

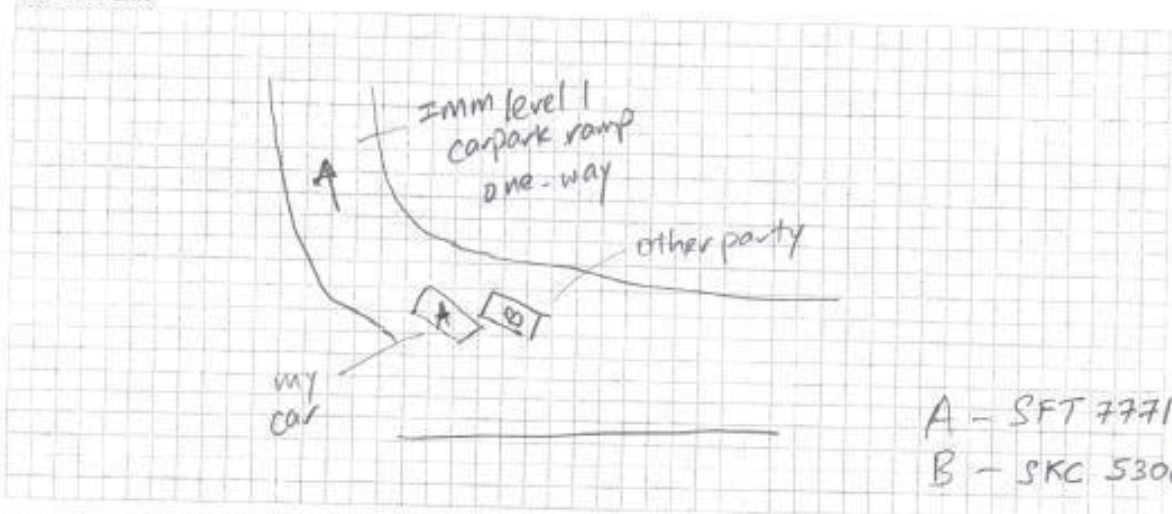

Vehicle A was ~~pre~~ about to drive up the carpark ramp at Imm multi-storey carpark (Level 1) when vehicle B ~~it~~ hit the rear right door. Vehicle B had tried to overtake <sup>vehicle A</sup> suddenly before entering the ramp. (Video footage available)

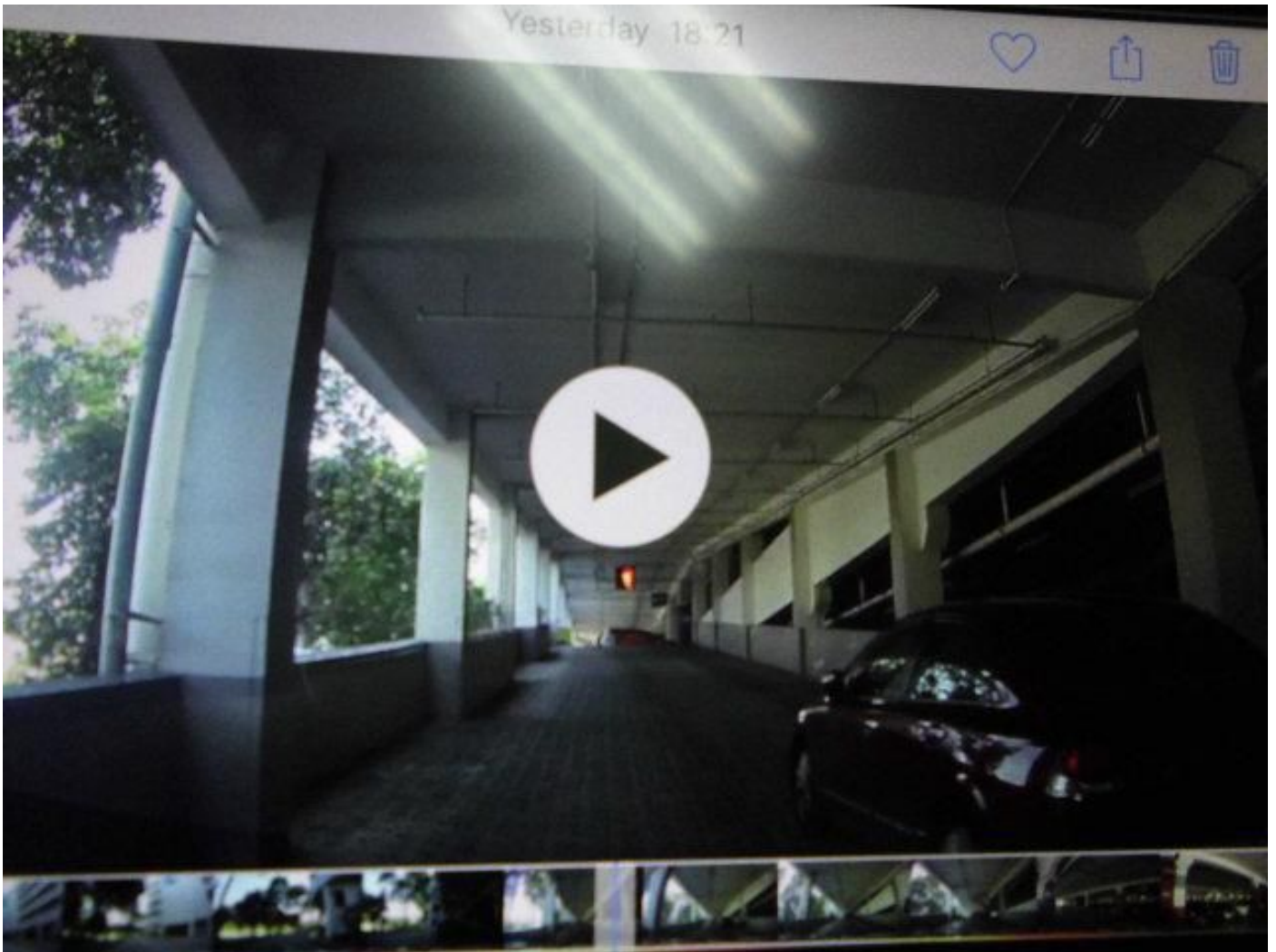

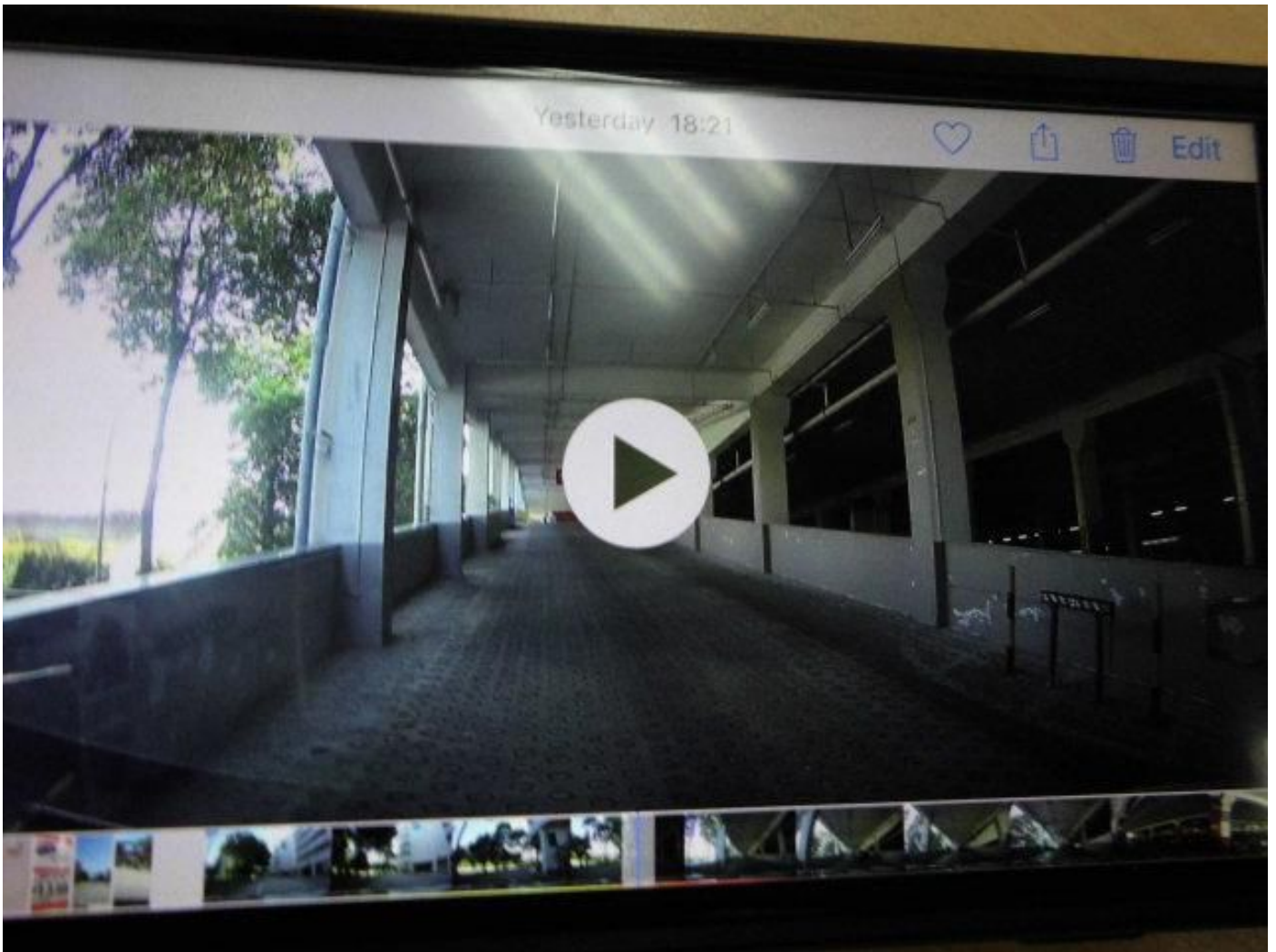

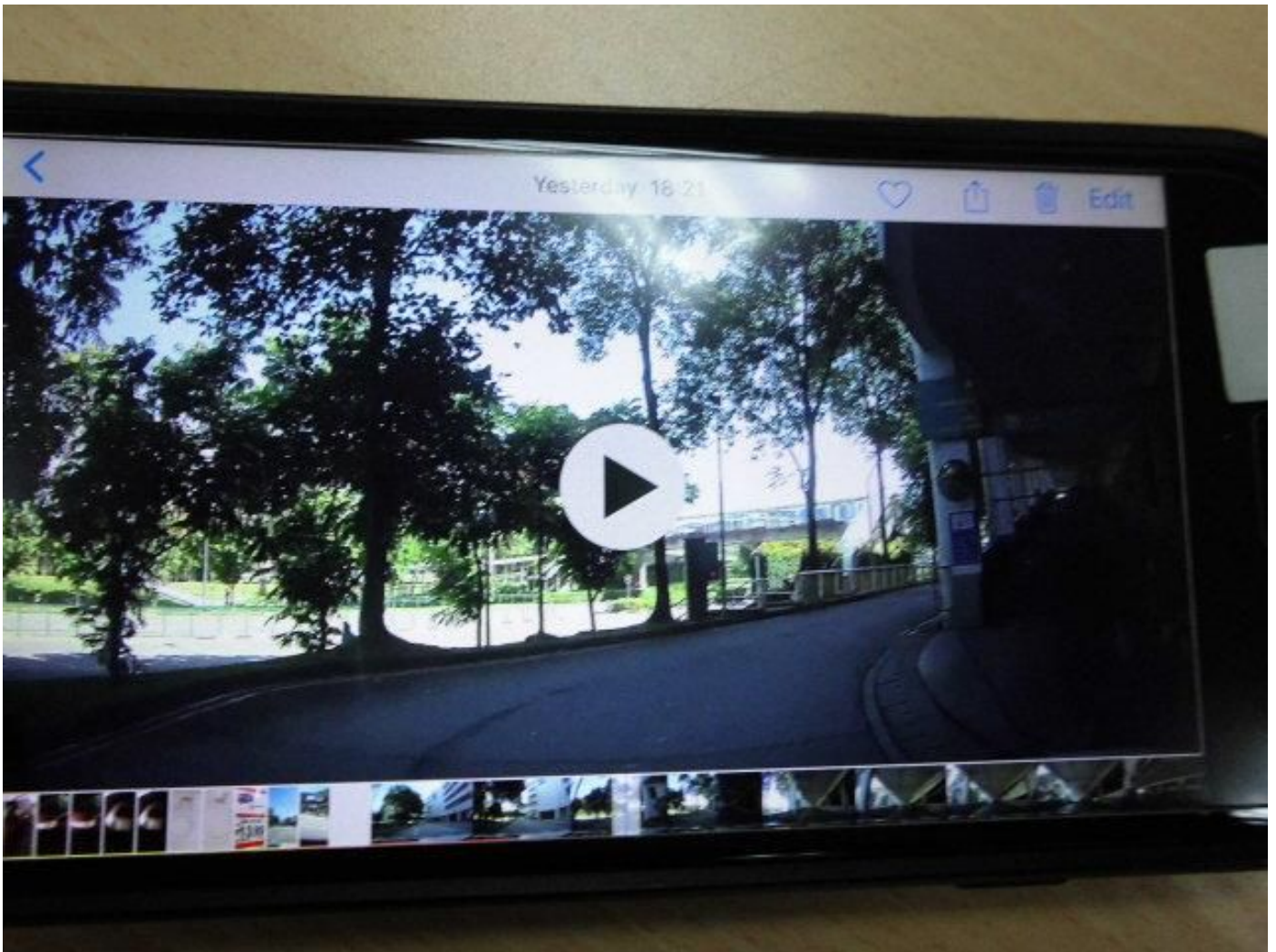
