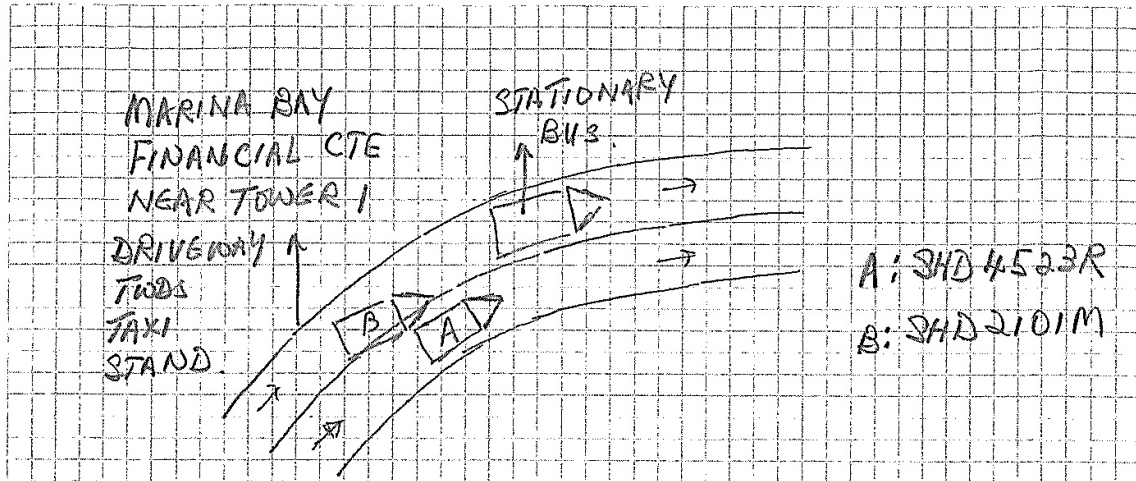

Describe Circumstances of the Accident
On 23 Jan 2018 at about 18:30 hrs the traffic volume was heavy and the traffic flow was slow
moving along the Marina Bay Financial Centre Tower 1 Driveway leading towards the taxi
stand direction.
Due to the traffic condition I was slowly driving on the right lane along the above driveway
heading towards the taxi stand to pick up the passenger.
As I was negotiating the bend stretch of the road at the same time maintained my taxi within
my lane suddenly I felt an coming from the left hand side rear of my taxi followed by a jerk.
Shortly after I stopped my taxi and stepped out to check. Found that a Prime taxi SHD2101M
had come from my left and filtered out to its right thus encroached into my lane and caused
this accident to happen.
In the process the right hand side front of the taxi hit and grazed the left hand side rear
including the left hand side rear wheel of my taxi thus damaging them.
No passenger on board my taxi. No injury at the point of the accident.

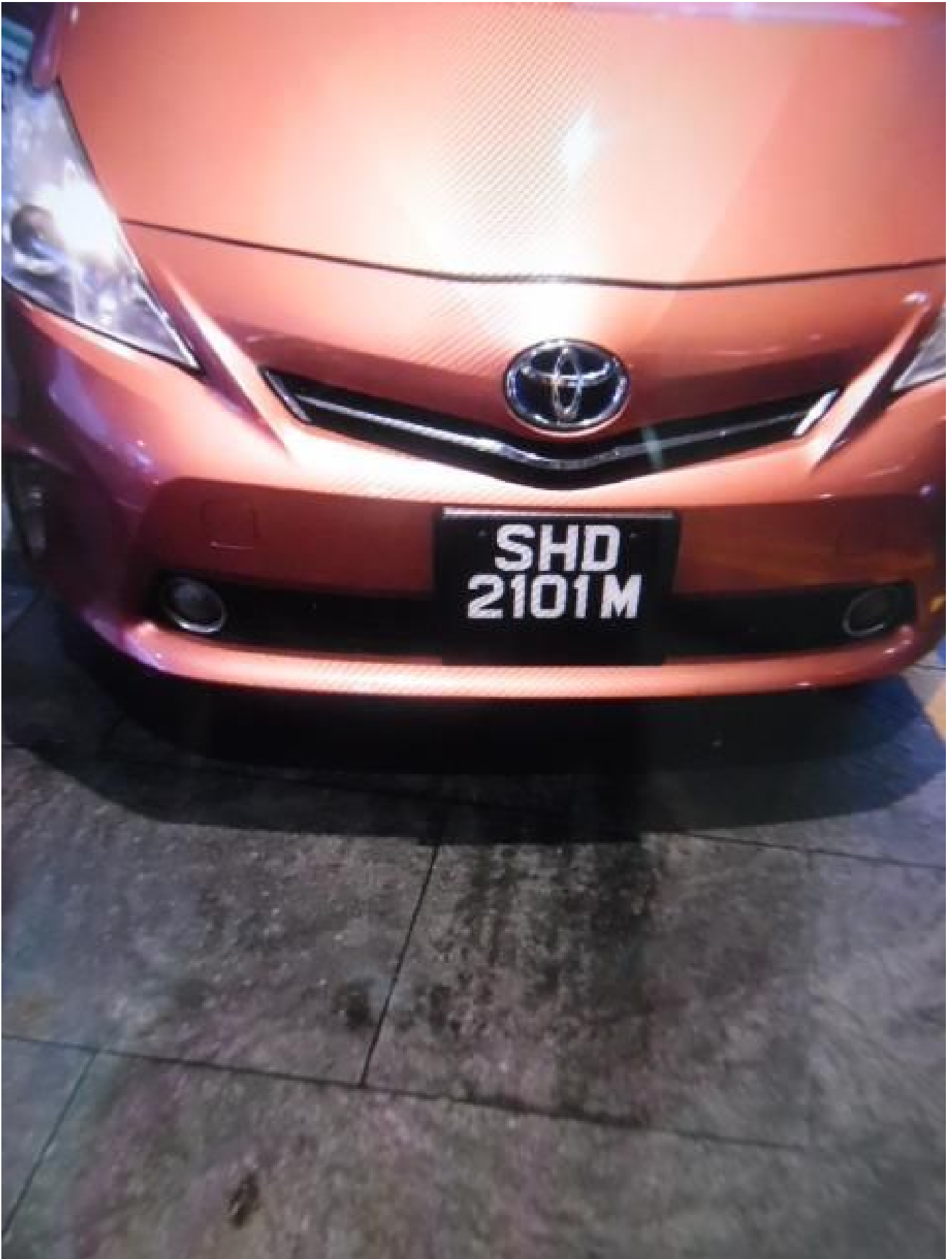

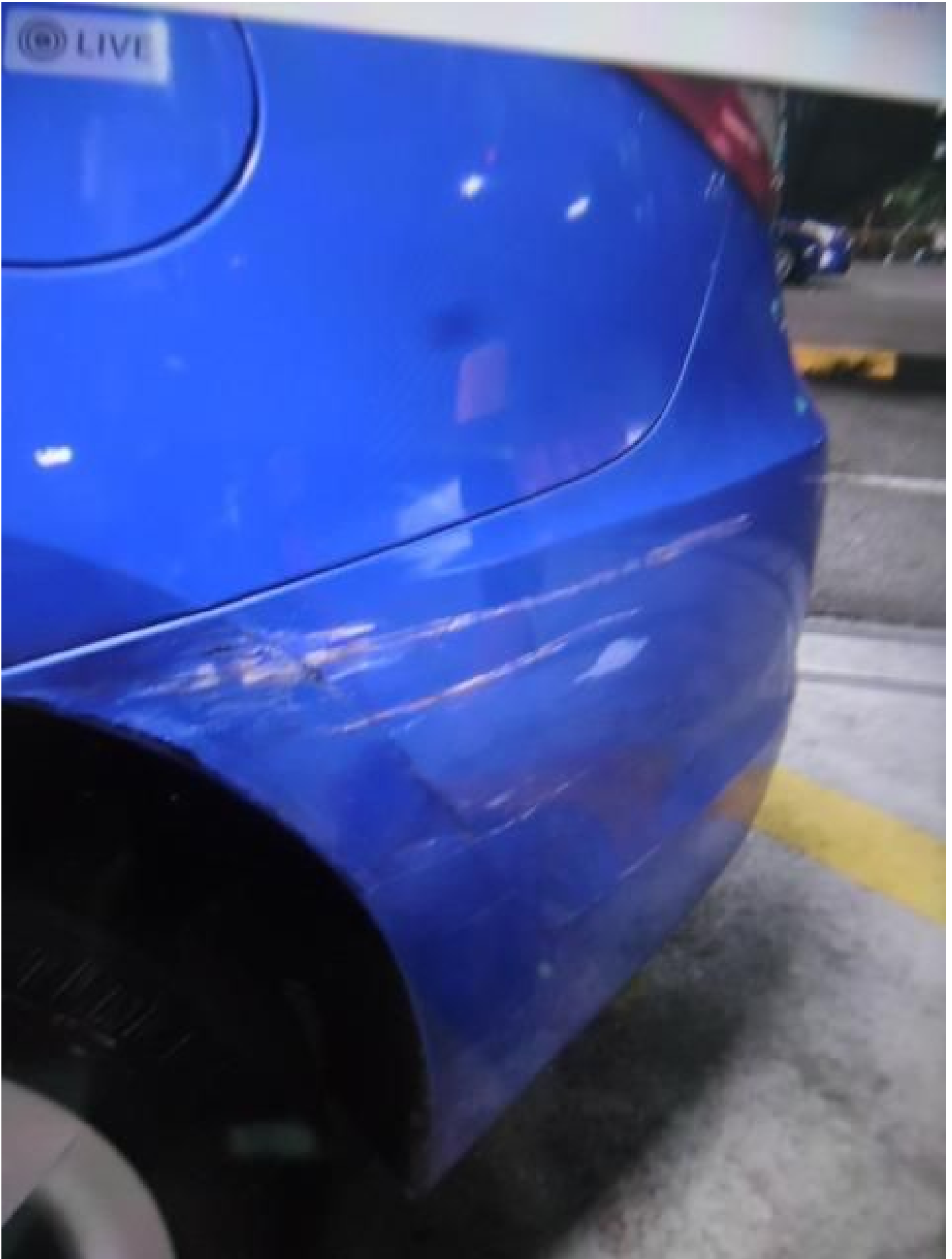
