

DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

Driving along Upper Bukit Timah Road towards Choa Chu Kang direction on 23rd January at approx 7.25pm. I was in middle lane behind a red Honda Jazz SJG 6304D. A motorbike on the right lane in front of the Jazz suddenly swerved into the middle lane causing the Jazz to brake hard. I stepped on my brakes immediately however the inertia of my vehicle resulted in contact with the Jazz. It was to be understood later that the rider on the bike had experienced an engine shut off and thus caused him to lose balance and momentum therefore he swerved and came to a stop in front of the Jazz.
