We refer to your below email.

Based on the Insured's video footage, the junction is non-signalized junction and the vehicles on the opposite lane stop before the yellow box and give way to Insured vehicle to make a turn. However, TP motorcycle (due to blind spot), drove straight across the junction and collision happened.

We had spoken to the Insured earlier where he strongly denied liability for this matter and that TP claimant is making a false statement. There is no update yet of his claim against TP and no update from Traffic Police either for the investigation.

We are also pending for evidence from TP if any.

Based on the enclosed Insured's video footage, we are of the view that TP is more liable of the accident.
