

#### 8. Consent under the Personal Data Protection Act (PDPA)

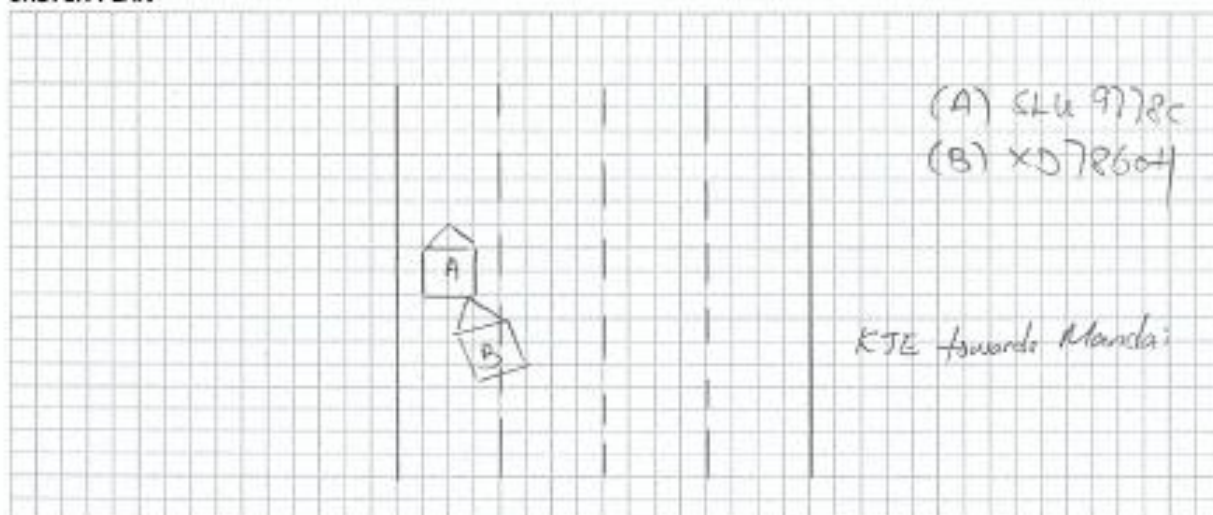

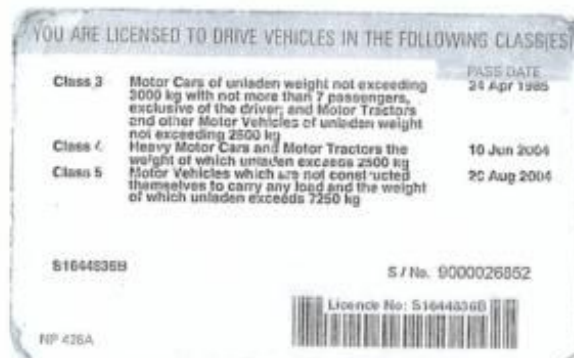

The Premium Warranty Clause requires the premium to be paid in full within a specific period failing which there would be no liability under the policy, renewal certificate, endorsement etc.

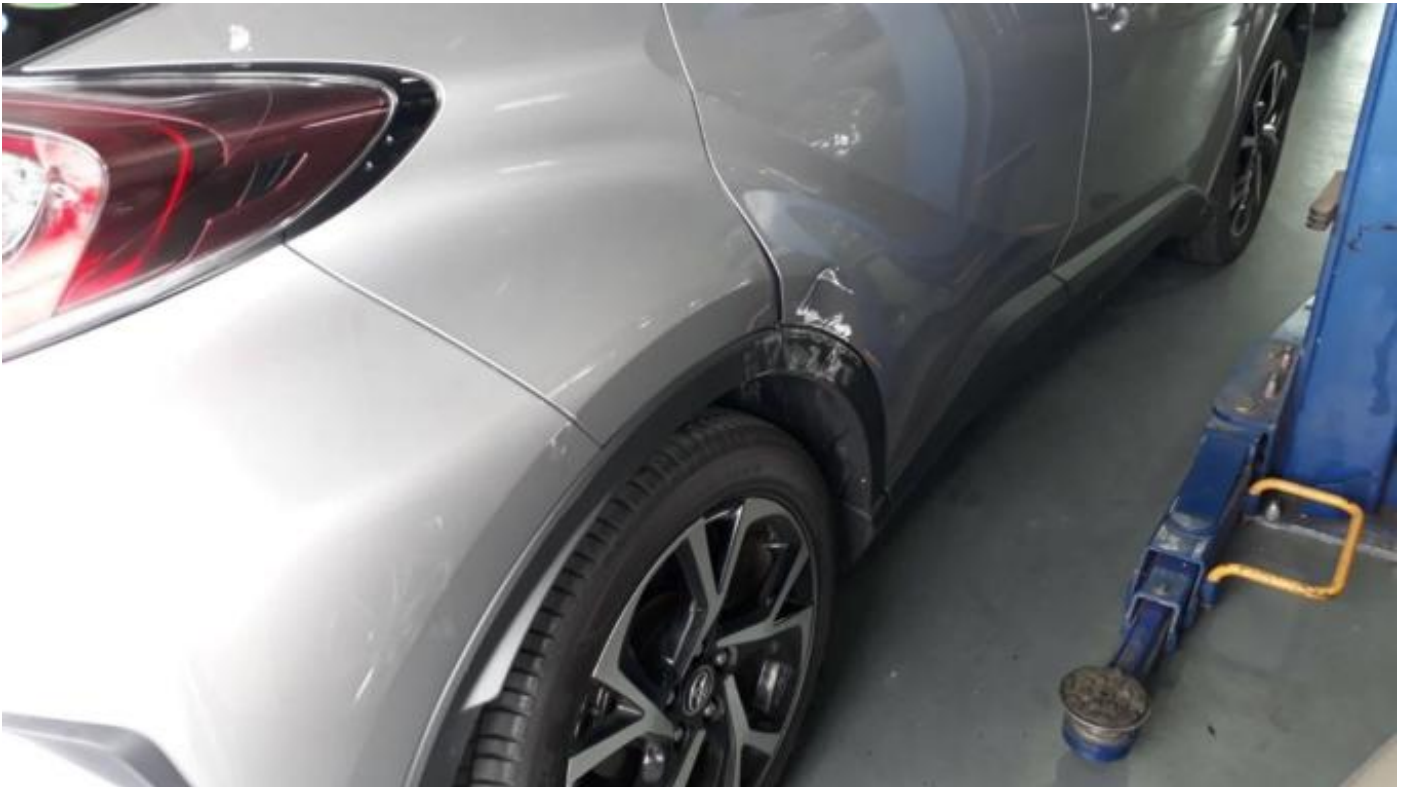
