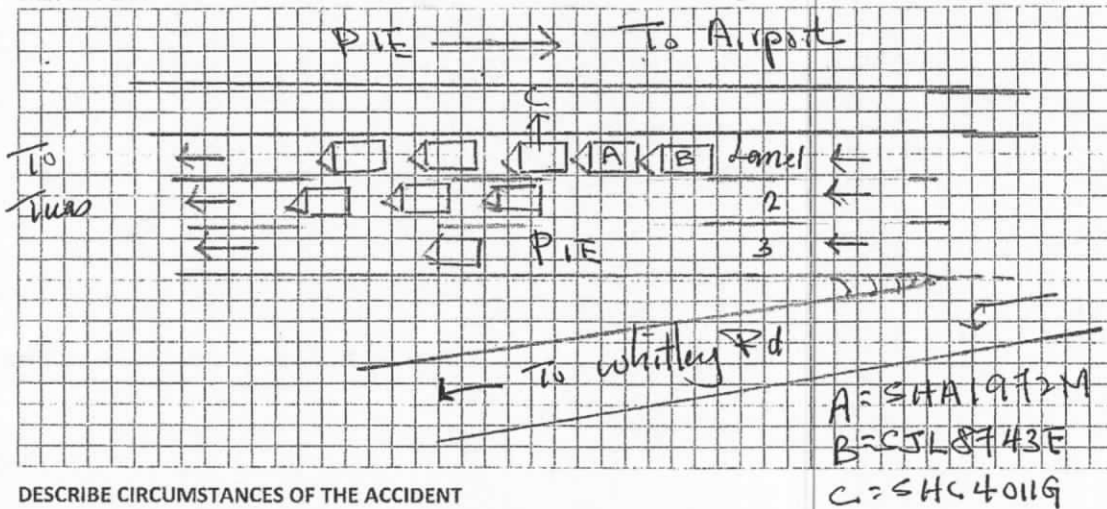

- ACCIDENT STATEMENT

Yesterday afternoon( 27/01/2018), I travelled on PIE ferrying a male passenger on the way to his destination at Jurong.

While moving on the fast lane, I braked quickly when I noticed front car C ( SHC 4011G), an SMRT taxi, halted abruptly near Whitley Road exit.

But instantly, I felt an impact after car B( SJL 8743E) behind hit into the rear of my taxi. There was also an minor impact between my taxi and car C.

When I alighted to check the cars involved. I saw the damage on rear portion of my taxi was substantive and the boot could not be opened up while there was very light level of dent on the front of my car.

The damage to the rear of car C was very minor.

However, damage to the front of car B was quite substantive.

I took photos at the scene and also exchanged particulars with the two drivers.

My passenger was not injured.
