



DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

On 20/01/2018 at about 3:00pm, I was travelling with my motorcycle bearing registration plate number FBL8295B along PIE towards Trus on the extreme right lane with a pillion.

At the point of time, the traffic was abt congested ahead hence, I slowed down by depressing my both brakes. Suddenly, the vehicle bearing registration plate SLG9278C came to a stop in front of me while braking. I try to avoid by steering to the left but there was car at the side.

Then my front tyre hit onto his rear bumper and then my pillion and I fall off from the <sup>R&P</sup> motorcycle. There was slight abrasion suffered from my pillion and myself. The car SLG9278C had a dent on the rear bumper and some scratches and paint peel of the rear boot door. My motorcycle FBL8295B front mudguard damaged as broke off and right front lens was bend.

There was no police report made as no medical attention or medical certificate. I did not installed any camera in my vehicle but the car SLG9278C had installed front and rear camera in the vehicle.
