
I understand, acknowledge, agree and consent that:



DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

On 30/01/2018, at about 0830h, I, Ang Guek Tin, NRIC No: S1516874 I was driving my car, SJS 8635Y (Car A) into the Queensway Underpass. In front of my car was another car, SKX 165B (Car B). The flow of traffic was very slow at that time. Suddenly, the driver of Car B stepped on the brake and his car came to a halt. I immediately stepped on my brake and managed to stop my car A without hitting Car B. No collision was involved. The driver of Car B, however, claimed that my car had hit his (that's Car B). I checked the car physically found no scratches nor physical damage on his car. The bonnet of Car A and the bumper of Car B were about 12 inches apart when both cars came to a halt. Nobody was also injured.
