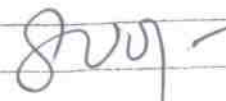

**a) Case: IAFP-IB-20180102 Mechanical Inspection of vehicle, Motor Bus, SBS3802J (TP/IP/60337/2017)**

On 8 November 2017 at about 6.26 am., motor bus SBS3802J was travelling along Jalan Boon Lay towards Boon Lay Way on the left lane of 3 lanes, when suddenly a pedestrian crossed the road from the right to left of the driver's view. Bus driver was unable to brake in time, hence collided onto the pedestrian. Pedestrian suffered serious injuries and was conveyed to the hospital. She succumbed to her injuries later on that day and passed away at the hospital.

**Pedestrian** - Deceased

**b) Case: IAFP-IB-20180102 Mechanical Inspection of vehicle, Motor Van; GBE6269C (TP/IP/59561/2017)**

On 03 November 2017 at about 4.39 pm., motor van GBE6269C was travelling along Mandai Road towards Yishun Avenue 1 on the left most lane of 3 lanes road when it collided onto the rear of a stationary tipper truck on the same lane. The van driver suffered fatal injuries and passed away at scene.
