Dear Bevan,

As per receiving your letter regarding the accident involving my vehicle GY 5056 S , taxi SHD 6439 M and a van GBB 8823 E.

When the accident happened on 31/01/2018, there is a vehicle along Paya Lebar Road towards Guillemard road

cutting across from lane 3 to lane 2 then to lane 1 into the path of the taxi SHD 6439 M. At this point, the vehicle made

a U-TURN causing the taxi to suddenly jammed braked and caused my vehicle and the van behind me to jammed brake avoid accident due to the sudden braking of the taxi. When i jammed brake, my vehicle already slowed down but still can't avoid knocking onto the

taxi. But the van behind me banged onto my rear of my vehicle. The lady taxi driver and I alighted from our vehicle to check on the damage. The rear of the taxi didn't show any damage and the lady driver also admits her vehicle is alright with no visible damage.

My vehicle front also not damaged due to the light impact. The driver behind me and I requested the taxi driver to provide us the video footage(from her dashcam)of the vehicle causing the accident so that I can file a traffic report against the errant reckless driver. But later the taxi driver changed her mind about giving us the footage giving lots of reasons. Even i asked her for that vehicle licence plate still she refused to provide us the information until now. Bevan, you acting for EQ insurance can ask for the video footage to see who is in the wrong cause we driver are the loosing end yet can't do anything without the footage. Partly the video can showed the taxi driver making sudden braking of her vehicle that caused the accident maybe the reason she or her company refused to provide the video footage to us.

Now they are claiming against my insurance when they them-self caused the accident. Please check the taxi for the damage before giving out the claim. If you can get the video footage I will file a report with traffic police and claim against the errant driver causing the accident. I have attached 2 photos for your reference.

The photo shows the rear of the taxi that has no damage mark. If you have any question, kindly please contact me on my mobile.

Please can update me on the outcome cause my NCD is at stake.
