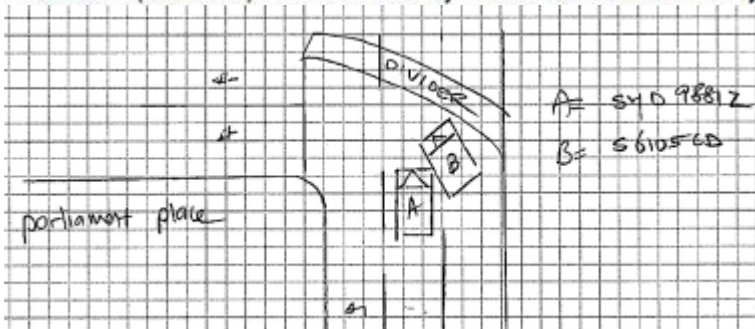
Refer to our tele-conversation.
