Brief Details.

ON 22/01/2017 AT ABOUT 2011HRS, I WAS RIDING MY M/CYCLE JSL 4503 IN LANE 2 BEDOK NORTH AVE 1 APPROACHING THE JUNCTION CHAI CHEE ST TOWARDS THE DIRECTION OF PIE. SUDDENLY A M/TAXI SHA8880Z MAKES A U-TURN FROM THE OPPOSITE DIRECTION. I THEN HONKED AT THE SAID M/TAXI AND I APPLIED MY BRAKES. HOWEVER, I DID NOT MANAGED TO AVOID THE COLLISION. MY M/CYLE THEN COLLIDED ONTO THE LEFT SIDE OF THE SAID M/TAXI. AND I WAS FLUNG ABOUT 3 METRES AND FELL ONTO THE ROAD SURFACE. THERE ARE PASSERBY WHO HAD ASSISTED ME AS I WAS RENDERED UNCONSCIOUS. I WAS THEN CONVEYED BY AMBULANCE TO CGH FOR MY INJURIES. I WAS TREATED FOR A FRACTURE RIGHT THIGH(FEMUR), I ALSO SUSTAINED SOME ABRASION ON THE BACK OF MY BODY, LIMBS AND HANDS. I WAS DISCHARGED FROM CGH ON 26/01/2018. I WAS GIVEN HOSPITALIZATION LEAVE FROM 22/01/2018 TILL 09/02/2018. I AM UNSURE OF THE DAMAGES ON MY M/CYCLE OR THE M/TAXI. THERE ARE WITNISSES BUT I WAS UNABLE TO GET THEIR PARTICULARS NOR CONTACTS. THE SAID ACCIDENT WAS ATTENDED TRAFFIC POLICE REF INCD G/20180122/0195. IN TWO WEEKS TIME I NEED TO COME BACK FOR A FOLLOW UP TREATMENT WITH CGH DOCTORS.
