Brief Details.

On 01/02/2018 at about 1030hrs, I was travelling along AYE towards MCE (after Jurong Town Hall Road Exit).

I was travelling on lane number 3 (XE3483J, UD TRUCK, GKB5ELDHT ESCOT V, WHITE) when the vehicle in front of me (YN9725M, MITSUBISHI CANTER FEB21ER3SDEB, White) suddenly slowed down, as such I slowed down my vehicle. Out of a sudden, I heard a loud bang from behind and the impact caused my vehicle to move forward and hit onto the rear portion of YN9725M. The vehicle YN9725M then hit onto the rear of a vehicle in front of him (XD9449A, VOLVO FMX370 64R DAYCAB, White).

I alighted from my vehicle and realized it was the vehicle behind me (XD9938E, ISUZU FXZ77M, WHITE) who hit my rear portion of my vehicle, causing damages to the front and rear portion of my vehicle. It was a chain collision and a total of 4 vehicles was involved.

Traffic police was at scene, and handed me a case card, and informed me to make a police report at any nearest police station vide incident D/20180201/0052.

Both the driver and passenger of YN9725M was conveyed to the hospital.

During the incident, I sustained minor injuries on the back and neck area. After the incident, I went to a
