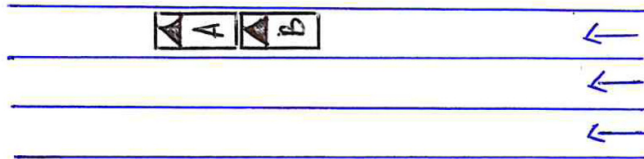


SKETCH PLAN

Ⓑ SKD 7655M



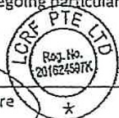
DESCRIBE CIRCUMSTANCES OF THE ACCIDENT
