#### Dear Zayer,

I do not agree with the settlement for the third party claim with regards to the accident involving vehicles SKH5896B and SGP7436M on 21/10/2013. I am writing to justify that her car has to be moving to collide into my car in order to cause the extent of the dent on her car.

Firstly, assuming that her car was stationary, it has to be in my line of direction in order for me to collide into her. Based on the area of collision and extent of damage on both cars (as shown in diagram 1), it is unlikely that the damaged side of my car is able to produce enough force to cause such dent on her car.

Furthermore, my car was moving at approximately perpendicular to the direction of the force required to cause the dent on her car (as illustrated in diagram 2). This means that there must be an external force to cause the dent on her car. Therefore, her car has to be moving and hit my car to cause the dent on her car.

#### Diagram 1





Diagram 2 (Assuming that she was in a stationary position)



Secondly, I was reversing. At the speed I was reversing, if she was in a stationary position, she should have had enough reaction time to prevent the collision, instead of remaining stationary and waiting to get hit. If she did not know I was reversing, my backlight would have given enough warning.

Moreover, I would like to question as to why her car was inside my parking lot when I was reversing. Therefore, this accident would not have happened if she was in a stationary position, unless she intended to park her car in that awkward position and was not in a proper state of mind to have a normal reaction time.

Thirdly, there is a camera fitted in the front of her car, which I believe is used as evidence for such accidents. I am sure that would serve as very important evidence. If her car was indeed stationary, I believe they would use this evidence to prove who was at fault. Thus, I feel that there is something suspicious if they refuse to show the recording, or claim that the camera coincidentally did not record anything on the day of accident.

I believe that the dent on her car should be sufficient enough to prove that she was the one who collided into me, as the damaged area of my car is very unlikely to have caused the dent in the direction I was moving towards. Thus, if the assumption that her car was stationary is true, her car should not have the dent. Therefore, it is logical to say that in order for a car to have such a dent, she has to collide into me.

I am in great disbelief that she changed her words and reported against me in her favour instead as she clearly admitted her mistake immediately after the collision, stating that she thought I was leaving the parking lot.


However, I do know that solid evidence is important for you to proceed with the negotiation without prejudice basis. I hope that you and your office would look into this case again as I feel that it is unfair for me to pay for someone else's careless and negligent driving.
