We refer to the above matter.

It was reported that the Insured vehicle was involved in a 3 vehicle chain collision and was the 2nd car and was pushed forward from behind then rear-ended TP vehicle.

We had spoken to the Insured Mr Ho and was informed of the TP claim and liability issues on 07/05/2018 and agreed to settle the matter. A letter was sent out to the Insured to inform about the TP claim and liability. No feedback from Insured till date.

In view of the above, we are of the view that liability is not to our Insured's favour and the damages sustained to TP vehicle were consistent to the nature of the accident.
