It was reported that the Insured vehicle was involved in a 3 vehicle chain collision and was the 2<sup>nd</sup> car and was pushed forward from behind then rear-ended TP vehicle.

We had spoken to the Insured Mr Ho and was informed of the TP claim and liability issues on 07/05/2018 and agreed to settle the matter. A letter was sent out to the Insured to informed about the TP claim and liability. No feedback from Insured till date.
