We did call OI to verify the nature of accident. OID disputed on the liability and he mention that he was travelling straight and TP coming out from MSCP and collided onto his vehicle.

We have reviewed both reports. Basing on available information, scenario from all involving parties, we are of the opinion that our insured is not liable for the accident as traffic on main road has precedence and vehicle approaching main road should exercise greater caution.
