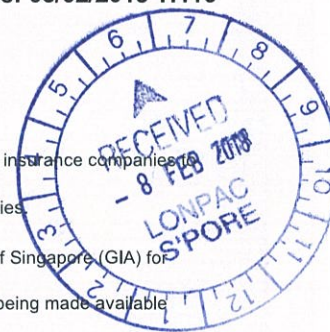

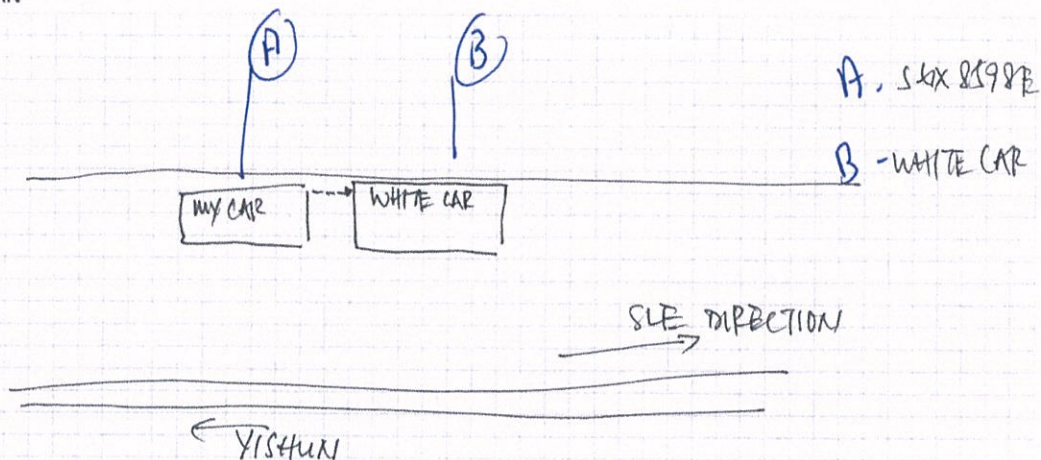

DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

AT FEB 2 ND 10 PM (ESTIMATE), I DROVE BY YISHUN DAM, STOPPED AT THE ROAD SHOULDER. AT THAT POINT OF TIME, I HAVE CONFIRMED MY CAR WAS PARKED AT THE ROAD SHOULDER. IN FRONT OF ME, THERE IS A WHITE HONDA CIVIC CAR PARKED WITH DISTANCE 5 FEET.
I AM CONFIRMED I DID SWITCH SWITCHED MY GEAR TO N (NEUTRAL) AND PULLED HAND BRAKE. HENCE, I STARTED ARRANGING MY STUFF INSIDE CAR. AFTER 5 MINUTES, I STILL CONTINUE ARRANGING MY STUFF AND UNTIL MY CAR CLOSE TO THE FRONT CAR. IMMEDIATELY, I DID REVERSED AND QUICKLY RUN TO CHECK ^{WITH} THE CAR OWNER STATUS. HE IS FINE WITH NO INJURY, CONTINUOUSLY TO CHECK THE BACK OF WHITE CAR, I DO NOT NOTICE ANY SIGNIFICANT BREAK OR TEAR. I DID ASKED THE OWNER FOR NO ^{PURPOSE} ACTION AND APOLOGIES IF ANYTHING HAPPENED TO HIM.
