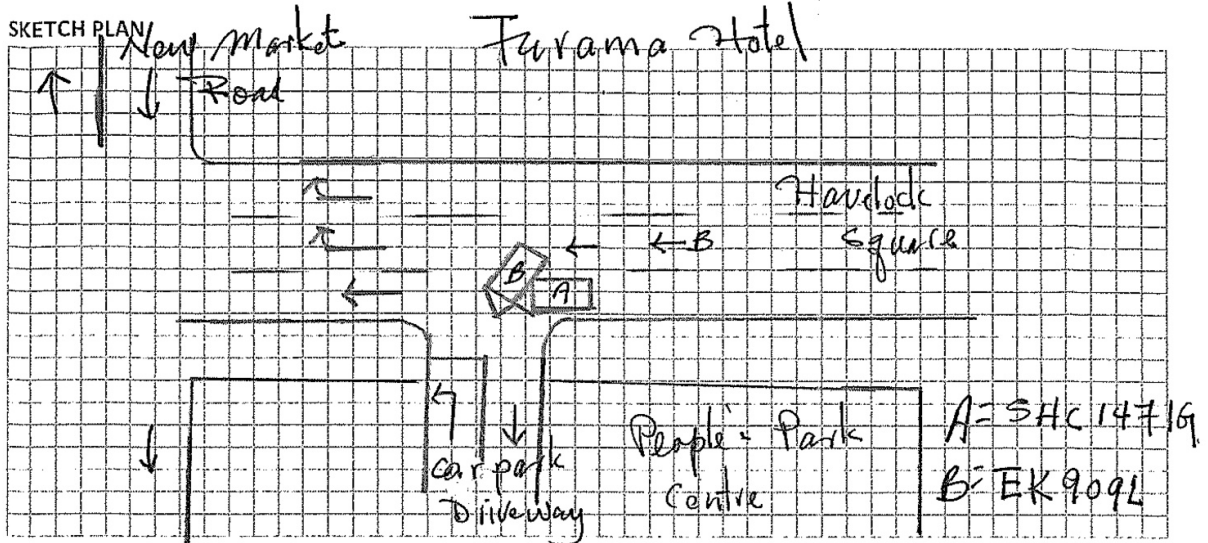

SHC 1471 G - ACCIDENT STATEMENT

Yesterday(04/02/2018) at around noon time, I fetched a female passenger to Havelock Square.

When I arrived at the destination, I stopped on leftmost lane for her to disembark.

After her departure , I kept a proper lookout and was sure it was clear traffic on the lane I was travelling before I set to move off.

As seen in the video, while I drove forward without speeding, my taxi was suddenly crashed into by car B(EK 909L) amid switching across to my path from the middle lane.

The middle lane and the rightmost lane on Havelock Square were right-turn lanes into New Market Road.

But car B switched into my path not only at fast disregarding the lane rule that it was on the track of a right-turn lane but also without signalling.

I took photos at the scene following the accident.

The impact inflicted damage to the right front of my taxi while the left rear to car B sustained dents.

The driver of car B, a male Chinese, declined exchange of particulars after the accident.

I affirmed the above-statement is true and correct.
