

Brief Details.

On the above mentioned date and time, I am riding my motorcycle along Seletar Expressway Lane 1 heading towards Bukit Timah Expressway, near to Woodlands Avenue 2 exit. The road was dry and the traffic volume was moderate. At that juncture, there was another ~~Singaporean motorcycle~~ in front of me and another Singaporean car bearing registration plate number EY9188S beside us. Suddenly, the car cut into my lane abruptly and knocked onto the motorcycle. I tried to stop in time but it was too late and collided onto the centre right portion of the car. I then fell onto the ground and was subsequently sent to KTPH via Ambulance. I suffered a suspected fracture on my right ankle and abrasions on my both legs and left hand. I was then given 15 days of MC. I was later asked by the Traffic Police to lodge an accident report.
