Brief Details.

On 5/2/2018 at about 1630hrs, I was driving on the 1st lane along PIE towards Tuas. As there were vehicles slowing down in front of mine, I decided to slow down my vehicle too. All of a sudden, I felt an impact from the rear of my vehicle.

Upon making a check, I realized that my car was involved in a 3-car chain collision. A vehicle had collided into the rear of another vehicle (EZ686A) which then collided into the rear of mine. I then pulled to the side and took photos of the damages while Traffic Police arrived shortly after. I was then instructed to lodge a police report in regards to the accident.
