Dear Ms Tan,

The accident happened long ago and these details are what I could still recall by using Google Street view.

- My friend and I were ordered a Grab car and boarded it on Kim Yam Rd.
- Not long after the driver turned right to Tong Watt Rd and there we stopped in front of The Wharf Residences where the accident took place.
- The female driver seem to had the intention to turn into the condo but then reverse back.
- That was when the rear of her car bang into our Grab vehicle.
- Instead of coming out of the vehicle and discuss the matter with the Grab driver, the female driver then drove into the condo.
- The Grab driver alight and went to talk to the security guard while we were waiting inside the Grab vehicle and not long after the female driver drove out of the condo passed the security gate.
- The female driver then drove towards Mohamed Sultan Rd and turned right into Kim Yam Rd and then turned right again to Tong Watt Rd where the accident took place.

- There I thought she would stop and settle the accident matter but to my surprised she just drove off towards Mohamed Sultan Rd again move off.
- Then our grab driver had no choice but to let go of the pursuit as we are still in the vehicle and drive us to our destination.

My friend and I were both NOT related or known any of the parties involved in the accident.

I would hope not to testify as a witness in the court but I am still willing to assist on the investigation as the female driver was irresponsible throughout the whole accident.
