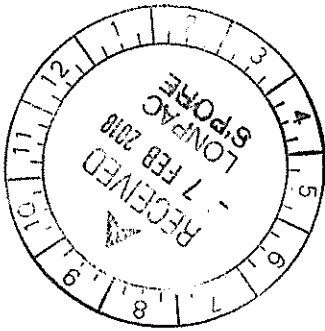

I STOPPED MY TAXI AS VEHICLES AHEAD WERE STATIONARY TOWARDS THE TAXI QUEUE.

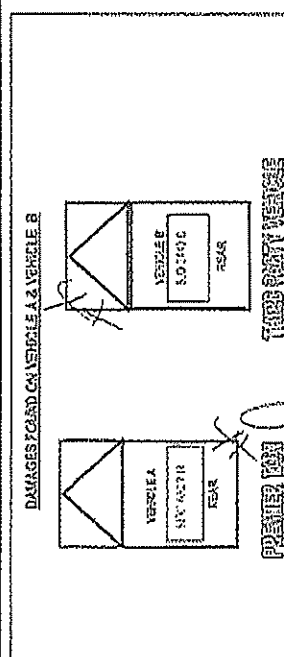
WHILE STATIONARY, SUDDENLY I FELT AN IMPACT FROM THE REAR.
