### Brief Details.

On 29/01/2018 at about 0640hrs, I was riding on my motorcycle, JPA4446, Yamaha red LC together with my pillion, Mohd Rusdi Bin Md Yusuf, work permit no: 4 05968282, Hp: 0145473690.

Along SLE towards BKE after Woodlands Ave 2 exit, I was travelling on the extreme right lane (1st lane) when a vehicle, EY9188S, Kia, grey colour, who was travelling on the 2nd lane to the right and change lane without signalling.

The side of the vehicle hit me as I can't escape and resulting me to hit the metal central divider. My motorcycle landed inside the central divider. I and my pillion landed on road of the 1st lane. Thereafter ambulance came and conveyed me and my pillion to Khoo Teck Puat Hospital. Traffic Police officer also came to the scene.

I suffered abrasion on the left cheek, left knee and left ankle. I was given outpatient treatment and 7 days of MC. I do not know the damage of my motorcycle. My pillion is still in hospital.

I am lodging this report as instructed by the TPIO.




