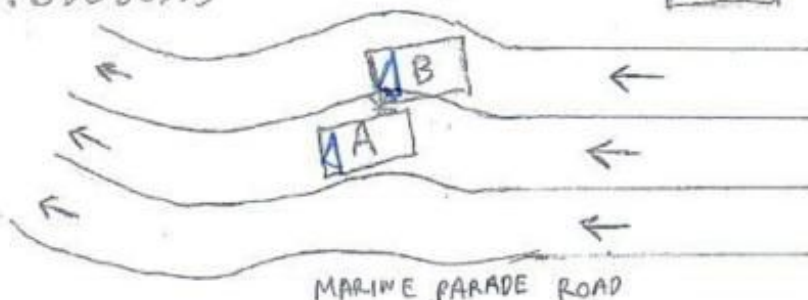

Describe Circumstance of the Accident *

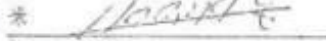
